Re: Complaint on Illegal occupation of the NRM District Party Office-Amuru by Mr. Nokrach William Wilson

We have seen our party grow tremendously in regard to unity, peace, transformation BUT most importantly the observance of the rule of law and upholding of the party constitution.

However, we the undersigned members of NRM wish to bring to your attention our observation that the current NRM District Party chairperson Mr. Nokrach William Wilson is occupying the office illegally when he decided to take unconstitutional path to contest as an Independent candidate for the position of the Member of Parliament (MP) for Persons With Disability (PWDs) Northern Region which is in contravention with Article 8 Clause 4 (c) and (e; iii) which states "**membership ceases if a member is found campaigning against the official candidate of NRM**" and in this case he has automatically lost his membership and therefore cannot be the Chairperson of NRM party in Amuru district.



We therefore in exercise of our duties enshrined in the Article 9 of the NRM constitution **demand** that the NRM Secretariat urgently Act on the following;
